The Duval County Appraisal District Board of Directors met in regular session on Tuesday, March 29th, 2016, with Mr. Adrian Perez, Chairman presiding.


### AGENDA:


- 16-036: Chairman, Mr. Adrian Perez called the meeting to order at 9:01 a.m.
